Eligibility Conditions/Terms & Conditions

1. Entries of all films / documentaries (hereafter collectively called films) shall be accepted only in DVD format.
2. Films made in the year 2015, 2016 & 2017 can only participate in 5th Darbhanga International Film Festival 2018. Films made before 1st January 2015 can't participate in the competition category.
3. There shall be three categories in the festival – **Mithilanchal**, **National** and **International**.

Mithilanchal Category: Only the films made by filmmakers of Mithilanchal region come under this category. The director(s) or producer(s) of the film must be a resident of Mithilanchal. (A residential proof ID must be attached with this film entry form). The films made by outsiders of Mithilanchal region can't enter this category. The films which are made in Hindi or regional languages of Mithilanchal region (like Maithili, Maghi, Bajjika, Angika etc.) can only participate in this category. Mithilanchal/Mithila Region, a proposed state of India is presently spread along 30 Districts of Bihar & Jharkhand states. These 30 Districts are East Champaran, West Champaran, Muzaffarpur, Vaishali, Sheohar, Sitamarhi, Samastipur, Darbhanga, Madhubani, Saharsa, Supaul, Madhepura, Kishanganj, Purnia, Katihar, Araria, Begusarai, Khagaria, Munger, Sheikhpura, Lakhisarai, Jamui, Banka, Bhagalpur, Deoghar, Dumka, Godda, Jamtara, Pakur, and Sahebganj.

National Category: Only the films made by the filmmakers of India come under this category. The director(s) or producer(s) of the film must be a citizen of India. (A document must be attached with this film entry form which proves your Indian Citizenship). The films made by outsiders of India can't enter this category.

International Category: There is no restriction for this category. Any film all over the world can participate in this category.

4. Films must be subtitled in English.
5. Films may be entered by any organization, agency, Individual producer or director.
6. Selection of films / videos for Darbhanga International Film Festival will be done by a committee whose decision will be final. However, Festival Authorities reserve the right to accept or reject any film that is likely to offend sentiments, feelings or sensibilities of any caste, community, religion, and sector is likely to promote racism or ill will in the society.
7. Darbhanga International Film Festival would be allowed to use all photographs and publicity materials received along with the entry and the same will not be returned to the entrants.
8. Censorship will not be applicable to any films / videos entered in the festival.
9. The Festival Authorities will have the right to screen the selected films (for awards) in India or abroad on non-commercial basis.

10. For promotional / publicity purpose, excerpts from any film entered in the festival may be shown on any Television Network / Internet or related media during the festival period.
11. Entry Forms with incorrect / inadequate / illegible / ambiguous particulars will not be considered.
12. DVDs submitted for selection will be considered as final and no changes will be entertained after submission. It is the sole responsibility of the applicant to submit DVDs without any physical / quality defects.
13. Prize and Certificate will be awarded to the director(s) or producer(s) of the film.
14. Films once selected and submitted for the final screening will not be allowed to be withdrawn under any circumstances, until the festival is over.
15. Participation in the Festival implies acceptance of these Regulations.
16. Decision of the Festival Authorities regarding all matters not expressly provided for in these regulations or which require interpretation of the clauses mentioned above shall be final and binding on all parties.

 2. Two DVD of the Film.
 3. Synopsis of the film 150 words.
 4. Casting / Credits please attach.
 5. About Director(s) (Bio Data) 150 words.
 6. Photograph of Director(s) and Producer(s) of the film.
 7. Still photographs of film (minimum two).
 8. Production Still (minimum two).
 9. Poster.
 10. Press Kit.
 11. Censorship (If you have censorship certificate from Govt. Of India, please attach photocopy).
 12. For Mithilanchal Category, a residential proof ID of Director(s) & Producer(s).
 13. For National Category, an ID or document of Director(s) & Producer(s) which proofs Indian Citizenship.
